OFFICE ORDER

The Director, NBSS&LUP, Nagpur is pleased to refix the rate/rent of Community Hall at Krishi Kunj Complex, Bajaj Nagar, Nagpur w.e.f. 01.01.2026 till further orders, as per the details given below :-

1. Fixed Charges/Rent :-

- a. Charges of Community hall Rs.23,000/- (Rupees Twenty Three Thousand only) for Wedding or Wedding reception (Booking amount - including water and cleaning charges) per day (for 24 hrs.)
- b. Charges for community hall Rs.8,000/- (Rupees Eight thousand only) for Birthday/Marriage engagement/Family function (Booking amount - including water and cleaning charges) per day (for 08 hrs.)
- c. At the time of booking 50% of the charge required to be paid.

2. Electricity Charges

Will be charged as per actual consumption at the rate of the MSEB norms.

3. Terms & conditions for allotment of Community Hall :-

- a. Community hall is allowed for working employees and spouse and first blood relation of the working employees as well as ICAR pensioners.
- b. Committee members will meet every six months and consider suggestion, if any for improvement and new proposal for further consideration in public interest.
- c. Prescribed application format with details will be prepared for purpose, Name, Address, Mobile No.ID Proof/Photo and other information.
- d. Parking of vehicle should be on appropriate place to ease the movement of guests.

4. Hall will be provided for following functions

- Marriage, Birthday/Marriage engagement/Family function etc.
- Organizing Welcome and welfare function of the Institute

5. **Restrictions :-**

- D.J. and Band etc. will not be allowed after 10.00 P.M. in the Krishi Kunj Premises, Bajaj Nagar, Nagpur
- No crackers allowed in the community hall premises.
- Consumption of alcohol is strictly prohibited in the premises

6. Cancellation :-

g. Cancellation: Cancellation would be allowed subject to the following conditions/deductions

- i. 10% if it is before 07 days
- ii. 25% if it is before 02 days
- iii. 50% if it is less than 48 hrs.
